A View from the Bench: Defend Trade Secrets Act Litigation

The Defend Trade Secrets (DTSA) statute went into effect in May 2016. Until its passage, parties had to rely on state uniform trade secrets acts for misappropriation claims. DTSA is an effort to nationalize misappropriation cases and to provide for damages for actual losses and unjust enrichment. Only several cases have been filed in Michigan federal court using DTSA, but more are expected. Compare the DTSA with the Michigan Uniform Trade Secrets Act (MUTSA), and gain Judge Roberts' important insights to bolster your litigation strategies in cases involving the DTSA. Hon. Victoria A.
